Remove samples of compressor oil and refrigerant for chemical analysis.
Refrigerant leak test chiller and document leaks found (repair "minor" leaks, if possible).
Transfer R-134A to storage tank for accurate weight of charge (Leaving 5psi on Chiller). Furnish and change compressor oil filters, and all driers.
Furnish and change gearbox oil filters and oil (*Gear/Motor Oil furnished by DuPont*).
Inspect gears and internal gearbox components. Disassemble motor coupling and check cold alignment. Repack motor coupling with grease and reassemble. Disassemble Compressor coupling.
Check compressor axial thrust readings. Check compressor coupling cold alignment. Reassemble coupling. Vacuum out compressor motor. Brush clean all oil cooler tubes (Gear & Compressor).
Transfer R-134A charge back into Chiller.
